## Agreements

*Memorandum of Understanding*

**Chequamegon-Nicolet National Forests**

USDA Forest Service and Wisconsin Department of Natural Resources

- Provides for the two parties to work cooperatively to protect and manage fish and game. A mutual agreement document implementing various authorities for the Forest Service and Wisconsin Department of Natural Resources (Formerly the Department of Conservation) to work together for the protection, development and use of forest, fish and game, lakes and streams etc.

***Memorandum of Understanding***

USDA Forest Service and Wisconsin Department of Natural Resources

- Provides for the protection and management of state designated wild rivers.

***Memorandum of Understanding***

USDA Forest Service and Indian Tribes of the Great Lakes Indian Fish and Wildlife Commission

- Outlines the relationships of sovereign and federally recognized tribes of Lake Superior Chippewa Indians and of the USDA Forest Service, an agency of the US government. The agreement establishes consistent standards by which the Forest Service and the Tribes interact across national forest lands within areas ceded in the treaties of 1836, 1837, and 1842. National forests in the ceded territory include the Chequamegon-Nicolet in Wisconsin, the Ottawa and Hiawatha in Michigan's Upper Peninsula, and the northern part of the Huron-Manistee in Lower Michigan.
